### Timeline of events




By 1750, Britain held lands in North America, the West Indies and India.



These places were known as **COLONIES** and together they made up the **British Empire**.

The colonies provided the raw materials needed to make finished products in Britain (like cotton for materials, spices for food, tobacco to smoke) - and then the *finished goods* were sold back to the colonies - **AT A PROFIT!**


Ran away from the undersigned, on Sunday the 9th inst., a negro boy named

## AARON OR APE.







## Key Words/Phrases

### Exploitation:

Treating someone unfairly to benefit from their work.

### Triangular Trade:

The three-part transatlantic slave trade that involved taking goods from Britain to Africa to exchange for people. Those people were then taken to America to work as slaves and exchanged for goods which were sold in Britain and Europe.

### Slave:

A person who was the legal property of another and was forced to work for no pay.

### Abolition:

The act of abolishing a system so that it is no longer permitted.

### Plantation:

An estate on which crops, such as coffee, sugar and tobacco are grown.

### Segregation:

The enforced separation of different ethnic groups in a country.

### Middle Passage:

The journey across the Atlantic Ocean that captured Africans were taken on, often in unsanitary conditions.

### Colony:

A country that is under full or partial political control of another country.

### Auction:

A public sale where goods are sold to the highest bidder.
